THROUGH THIS PROJECT WE BUILT A SPECIALIST CLINICAL FACILITY THAT WAS COMPLETED DURING 2012, ARE ACTIVELY SUBSIDIZING FISTULA CARE, SPONSORING TEAMS OF QUALIFIED SURGEONS AND NURSES TO PROVIDE FISTULA CARE, AND TRAINING AFRICAN AND OTHER HEALTH PROFESSIONALS IN FISTULA CARE.
