WORLDWIDE FISTULA FUND (WFF) OPENED A NEW FISTULA HOSPITAL IN DANJA, NIGER, IN 2012 OFFERING FREE FISTULA REPAIR SURGERY, REHABILITATION, AND A REINTEGRATION/VOCATIONAL SKILLS PROGRAM. 1,548 SURGERIES HAVE BEEN PERFORMED SINCE OPENING IN 2012. WORLDWIDE FISTULA FUND SUPPORTED TRAINING FOR DANJA FISTULA CENTER'S AFRICAN SURGEON TO BECOME A CERTIFIED EXPERT IN FISTULA SURGERY. ALL PATIENTS HAVE THE OPPORTUNITY TO LEARN VOCATIONAL SKILLS THEY CAN USE TO GENERATE INCOME, BUILD SELF-CONFIDENCE, AND HELP THEM REINTEGRATE INTO THEIR COMMUNITIES.

WFF HELPED LAUNCH THE REINTEGRATION CENTER IN SOROTI, UGANDA IN 2013 WHICH SUPPORTS COUNSELING, LITERACY EDUCATION, AND ENTREPRENURIAL SKILLS TRAINING FOR WOMEN WITH FISTULAS, AS WELL AS TRAINING FOR COMMUNITY-BASED ADVOCATES TO PROVIDE PREVENTION EDUCATION, TREATMENT REFERRAL, AND SURVIVOR SUPPORT NETWORK PROGRAMS. WFF HAS SUPPORTED 938 SURGERIES AND 635 WOMEN RECEIVING REINTEGRATION TRAINING TO DATE.

SINCE 2013, WFF HAS PROVIDED ENHANCED RESIDENCY TRAINING IN OBSTETRICS AND GYNECOLOGY THROUGH THE MEKELLE MEDICATION EDUCATION COLLABORATION (MMEC) FOR STUDENTS, RESIDENTS AND FACULTY AT MEKELLE UNIVERSITY IN ETHIOPIA.
