WORLDWIDE FISTULA FUND OPENED A NEW FISTULA HOSPITAL IN DANJA, NIGER, IN 2012 OFFERING FREE FISTULA REPAIR SURGERY, REHABILITATION, AND A REINTEGRATION/VOCATIONAL SKILLS PROGRAM. MORE THAN 1000 SURGERIES HAVE BEEN PERFORMED SINCE OPENING IN 2012. WORLDWIDE FISTULA FUND SUPPORTED TRAINING FOR DANJA FISTULA CENTER'S AFRICAN SURGEON TO BECOME A CERTIFIED EXPERT IN FISTULA SURGERY. IN 2016, HE PERFORMED 212 SURGERIES, INCLUDING 195 FISTULA SURGERIES AND 17 PELVIC ORGANS PROLAPSE SURGERIES.
